**ORDER**

As per the item No.11.17 of the meeting of the Senate held on 21-08-2018 the Clause 2.8.2 of the Calicut University Research Regulation 2016 proposed by the Syndicate "Clause 2.8.2 - Teachers of the Universities /Government or aided Colleges in the state of Kerala and the teachers of the Government or aided Secondary / Higher Secondary School within the Geographical jurisdiction of the University /employees of the University and holding a permanent position there are eligible for admission to Ph.D. Programme satisfying the conditions of Clause 2.1 of the Calicut University Research Regulation 2016 may be granted Part-time registration" has been approved.

Accordingly, as per the reference cited 1<sup>st</sup>, the Calicut University Research Regulation 2016 Clause 2.8.2 amended as "Teachers of the Universities /Government or aided Colleges in the state of Kerala and the teachers of the Government or aided Secondary / Higher Secondary School within the Geographical jurisdiction of the University /employees of the University and holding a permanent position there are eligible for admission to Ph.D. Programme satisfying the conditions of Clause 2.1 of the Calicut University Research Regulation 2016 may be granted Part-time registration".

But in the references cited 2, 3 & 4, with respect to this amendment it is furnished as "Teachers of the University / Government or Aided Colleges within the geographical jurisdiction of the University" instead of "Teachers of the Universities /Government or aided Colleges in the state of Kerala".

In the above circumstance, as per the reference cited 5<sup>th</sup>, in the University Orders referred as 2, 3 & 4 the term "Teachers of the University / Government or Aided Colleges within the geographical jurisdiction of the University" with respect to the amendment to Clause 2.8.2 is modified as "Teachers of the Universities /Government or aided Colleges in the state of Kerala".

The university orders referred as 2,3 and 4 above are modified to this extent.
