ORDER

As per the reference cited 1st, the Principal, Christ College, Irinjalakuda submitted an application for recognising the Department of Commerce of the College as Research Centre of the University.

Considering the request, the Vice-Chancellor, vide reference cited 2nd, appointed Dr. K.D. Bahuleyan (Member of the Syndicate), Dr. B. Johnson, Professor, Department of Commerce and Management Studies, University of Calicut (subject expert) and the Director, Directorate of Research as members of the Research Recognition Committee to inspect and report on the facilities available in the Department of Commerce, Christ College, Irinjalakuda to consider the application for recognising it as a Research Centre of the University.

The Committee inspected the Centre and submitted its report vide reference cited 3rd, which unanimously recommended to grant recognition to the Department of Commerce, Christ College, Irinjalakuda as Research Centre of the University with a suggestion to visit the research centre after one year of its recognition.

The matter has been placed before the Syndicate for consideration. On the basis of the report of the Research Recognition Committee and as per the reference cited 4th, the Syndicate at its meeting held on 17-05-2021, has resolved to grant recognition to the Department of Commerce, Christ College, Irinjalakuda as Research Centre of the University vide item No. 2021.436*, with the directions detailed in pre-para.

Sanction has been accorded by the Vice-Chancellor, as per the reference cited 5th, to implement the resolution of the Syndicate dated 17-05-2021 vide item No. 2021.436*, granting recognition to the Department of Commerce, Christ College, Irinjalakuda as Research Centre of the University.

Provisional recognition as research centre is granted to the Department of Commerce, Christ College, Irinjalakuda for a period of five years and permanent recognition will be granted only after reviewing the performance of the Centre at the end of the fifth year as per the Research Regulations of the University.
