ORDER

As per the paper read as first above, the Principal, St. Thomas College (Autonomous), Thrissur has submitted application for renewal of recognition of the Department of Economics as Research Centre of the University of Calicut.

As per the University Order read as second above, Research Recognition Committee was constituted to inspect and report the facilities available in the Department of Economics at St. Thomas College (Autonomous), Thrissur, for renewal of recognition as Research Centre. After conducting the inspection, the Research Recognition Committee submitted the report read as third above, recommending to grant renewal of recognition to the Department of Economics at St. Thomas College (Autonomous), Thrissur as Research Centre of the University of Calicut for a period from 07.03.2018 to 06.03.2028. The committee also recommended the following:

- (i) Centre should strive to attract participation of international resource persons in seminars or lectures.
- (ii) Centre may focus more on promoting the research guides from the college, to improve research quality.

3. As per the paper read as fourth above, the Syndicate at its meeting held on 07.11.2025 resolved vide urgent Item No. 2025.1212* to grant renewal of recognition to the Department of Economics at St. Thomas College (Autonomous), Thrissur as Research Centre of the University of Calicut approving the recommendation of the Research Recognition Committee.
