After examining the matter in detail, The Vice Chancellor ordered to place the matter before the Standing Committee on Courses & Research.

As per paper read as (2) above, the Standing Committee on Courses & Research at its meeting held on 12-03-2018 recommended to approve the matter of finalising the specific title of research by the supervising teacher before the pre-submission presentation for scholars who have registered for Ph.D. under 2016 Regulations.

As per paper read as (3) above, the Syndicate at its meeting held on 15-03-2018 and 16-03-2018 vide item no. 2018.364\* has resolved to approve the recommendation of the Standing Committee on Courses & Research that the specific title of research shall be finalised by the supervising teachers before pre-submission presentation for scholars who have registered for Ph.D. under 2016 Regulations.

Sanction has therefore been accorded by the Vice Chancellor on 22-03-2018 to implement the Syndicate resolution dated 15-03-2018 and 16-03-2018, vide item No. 2016-1140\* and to permit the supervising teachers to finalise the specific title of research before the pre-submission presentation for scholars who have registered for Ph.D. under 2016 Regulations.
